

## PERMISSION TO TRAVEL FORM FOR MINORS

Minors under the age of 18 traveling from the United States to any foreign country must have a notarized affidavit from the child's parent(s) or legal guardian(s). The Notarized affidavit must clearly include the following statements:

- 1. The child is traveling out of the United States with the permission of the parent(s) or legal guardian(s),
- 2. The parent(s) or guardian(s) legal relationship with the child,
- 3. If one of the parent(s) or legal guardian (s) is traveling with the minor, the non-traveling parent(s) or legal guardian(s) is aware that the child is leaving on the departure date, and
- 4. The name(s) of the person(s) accompanying the child.

<u>Both parents or legal guardian(s)</u> must sign the permission form, which <u>MUST</u> be notarized. If the parents are not together, parent consent from both parents is still necessary. If one parent is the sole custodial parent or if one parent is deceased, there <u>MUST</u> be legal proof/documentation of this status. Parent(s) and/or legal guardian(s) must also attach copies of their identification documents and certified copies of a birth or adoption certificate, certificate of guardianship, marriage certificate, or custody agreement.
