

Starting Your Troop Bank Account

When opening a Girl Scout Troop bank account, the bank might require some documentation. Please call the bank prior to your visit to ensure you have all the required information in order to open the account. The bank may request a letter authorizing the holder to establish a bank account on behalf of the Girl Scouts. They also may request a letter verifying your membership with the organization. Both letters can be provided by your Community Engagement Manager. Please see below the list of Community Engagement Managers for the Girl Scouts of Eastern Missouri. Please included in your request: your name, troop number, cosigner's name and where the letter should be sent. Please allow 2-3 business days to fulfill your request.
