

Starting Your Troop Bank Account

Each Girl Scout Troop is responsible for setting up and keeping track of their own bank account. A bank account can be set up after the Troop has a Leader and an Assistant Leader in place. The signers do not have to be the Leader and/or Assistant Leader, but they do have to be registered, background checked adults.

It is recommended that all signers for the Troop Bank Account complete **Course 2: Troop Money Management** located in **gsLearn**.
